- The FLEX base level membership includes one full family golfing membership (termed the Primary membership). The objective of FLEX is to make it more affordable for your organization to add golfing memberships. Additional full family golfing memberships are offered in the following three age-related categories:
  - Premier
  - Young Professional I
  - Young Professional II
- As a further incentive to add golfing memberships, FLEX offers multiple membership discounts for up to four Premier memberships. The dues discount is distributed evenly over the Primary membership and the individual Premier memberships. Fee structures are provided with the Flex Program Addendum.
- The FLEX Primary membership has the same voting privileges as an individual golf membership. FLEX Social and additional Golfing memberships do not have voting privileges. The Primary member is eligible for election to the Board of Directors, and if elected, may serve their term if they are the Primary member.
- Social Designees have access to 5 rounds of golf per year on a pay as you play basis, social & dining events, including holiday & club functions, swimming pool & tennis courts.
- A designee must be an employee of the company. Board of Trustees, Attorneys or other affiliates are not eligible under this program.
- For those with a need for more than six Social memberships, a package of six additional memberships is available for total dues of \$200 per month for all six. Each additional membership also requires a \$50 per month food and beverage minimum when active.
